NOTES:

- **A refundable deposit of \$100 must be made before or on collection of the equipment.**
- **To comply with the QLD Agricultural Chemical Distribution Act, motorised herbicide delivery apparatus can only be used on private land by the owner of that land (or a member of their immediate family) or by someone with a Commercial Operator’s Agricultural Chemical Distribution and Control Licence.**
- *Each site requires site specific recommendations for best practice land management advice in the context of current Local, State & Federal Governments Environmental regulations.*
- *Recommended management practices are developed in consideration of Landholder long term intended use for the site and the best way of achieving these outcomes.*
- **WCL will not be complicit in the deliberate destruction of endangered vegetation types or habitats or illegal vegetation clearing and will advise the client of this potential conflict in the initial project discussion phase.**

The WCL Quikspray is available to eligible land managers to assist with weed control on private property.

This motorised spray unit can hold 600 litres of chemical to be applied at variable pressures via a 9HP pump. The 2 hose reels enable 2 users to spray weeds up to 80m away from the unit; and they rewind at the press of a button. This unit is useful for areas of heavier or extensive weed infestations.

As a motorised herbicide delivery apparatus, to comply with the Agricultural Chemical Distribution Act, it is only useable on land owned by the user or a member of their immediate family, or by someone with a Commercial Operator's Licence.
